WHO IS A PERSONAL REPRESENTATIVE UNDER HIPAA?

HIPAA recognizes that at times individuals are unable to exercise their rights or choose to designate another individual to act on their behalf. Under the HIPAA rule, a person authorized by law to act on behalf of the individual in making health care decisions, such as an individual named as health care power of attorney, is the individual's personal representative. (Additionally, the conditions to invoke the health care power of attorney must also be met – i.e., the patient is declared incapacitated.)

Other individuals who are recognized as personal representatives include: For an adult or emancipated minor

- A court appointed legal guardian
- A general or durable power of attorney that includes the power to make health care decisions

For an unemancipated minor

- A parent, guardian or other person with legal authority to make health care decisions on behalf of the minor child.
 - o Exceptions are:
 - When law does not require the consent of a parent, i.e., mental health treatment
 - When someone other than the parent is authorized by law to consent for the minor, i.e., a court of law or an individual appointed by the court.
 - When the parent agrees to confidentiality between the minor and the health care provider.

For a deceased person

• A person with legal authority to act on behalf of the deceased person or the estate. For example, the executor or administrator of the estate, next of kin or other family member as authorized by law.

Abuse, Neglect and Endangerment Situations: If a health care provider reasonably believes that an individual may be subjected to domestic violence, endangerment, abuse or neglect by the personal representative, the health care provider may choose not the treat that person as the patient's personal representative in the best interests of the patient.

HIPAA FAQ

Does a power of attorney give me the authority to obtain my mother's medical records?

There are many types of powers of attorney. For example, if the power of attorney only grants rights over financial matters and not rights to make healthcare decisions, then you cannot be provided copies of your mother's medical records. Therefore, the power of attorney must be reviewed carefully prior to releasing medical records to ensure that records are released only as authorized.
